The theme of research: the phenomenon of generational succession as an important factor in the preservation of national identity: a socio-philosophical analysis.

The purpose of the research is to provide a socio-philosophical justification of the succession of generations as one of the main factors shaping national identity and to analyze the prospects of the problem of identity in the context of modern global trends.

Research objectives:

- to give a logical analysis of the concept of succession of generations, to reveal the socio-cultural foundations and the relationship between the concepts of "generation" and "succession";
- to develop a classification of various natural-biological, historical, socio-political, psychological and other aspects of the succession of generations and their philosophical and theoretical interpretation;
- to substantiate a consistent logical definition of the concept of national identity through its comprehensive analysis and philosophical reflection;
- to reveal the socio-philosophical foundations of the essence and significance of the category of generational succession in the formation and preservation of national identity;
- by clarifying the ideological and theoretical foundations of the preservation of the nation, taking into account the continuity of generations, to justify the need to comprehensively strengthen the foundations of national security in the modern information space;
- to clarify the conditions for the preservation and transformation of national values in the country, taking into account the peculiarities of the multiculturalization process through the mentality of the modern generation;
- analyzing on a socio-philosophical basis the importance and role of generational succession in preserving national identity in the era of today's globalization, on a futurological basis, to assess the strategy for further improvement of national identity formulated in the national idea "Unity of the Nation".

Research methods: In order to implement the objectives of the research work, the following methods were used: concrete unity of historical and logical - in the study of problems of generational continuity and national identity in the modern era; integrity and consistency – in the study of the uniqueness of this continuity; synergetics – in the differentiation of national being as a self–regulating system and bifurcation of open systems; philosophical hermeneutics and phenomenology - in the study of succession problems; generations and national identity based on historical texts and differentiation of its manifestations in consciousness; psychoanalysis – in explaining the features of national consciousness; the genetic method – in a deeper study of the origin of each phenomenon on the topic under study. These techniques and methods in their interrelation according to the dialectical – logical methodology of ascent from the abstract to the concrete contributed to the achievement of true research results.

The main provisions put forward for defense (scientific hypotheses and other conclusions that make up the novelty are proved):

- the concepts of generation and succession are specifically logically analyzed, their relationship and interrelation are determined. Continuity is a broad concept with a variety of forms of its manifestation. It expresses a natural evolutionary, hereditary process of interrelation of the past, present and future. The succession of generations is a necessary and basic condition for the development of mankind;
- the development of society is conditioned by the change of generations, therefore, the formation of continuity between them is a non-profitable phenomenon with deep socio-psychological foundations. In the life of mankind, each generation is formed by a community of individuals with rich creative potential, and only thanks to the results of active activity of successive generations, society develops, cultural and spiritual progress takes place;
- for an in-depth understanding of the concept of national identity, it was necessary to turn to such concepts as nation, ethnos, nationality, ethnic nation, civil nation, and based on the dialectically contradictory correlation of these concepts, the illegality of such an artificial formation as "nation state" was proved. Emphasizing the fact that representatives of national communities must have "bonds of mutual care and loyalty", it was shown that the horizon of the concept of "civil nation" is limited in a number of democratically developed states, where it coexists with the concept of "ethnic nation", entering into a confrontation with it;
- through a critical analysis of the relevant concepts, the position was substantiated that one of the main mechanisms for the preservation and development of national identity lies in the succession of generations. The succession of generations leaves its mark on the history of human development, without which there is neither the history of mankind nor the history of the nation:

Based on the socio-philosophical analysis, an optimal system of measures to ensure the security of the country was proposed, without which there can be no national identity. The national identity of the Kazakhs, along with the "bonds of mutual care and loyalty", as shown in the dissertation, is based on national identity and national values, cultural traditions, as well as indigenous Kazakh properties.

- one of the important issues is a critical understanding of the relationship between modern postmodernism and multiculturalism as factors of preserving national identity, which corresponds to the platforms within the framework of the national idea that our country adheres to, strategic guidelines important for preserving the historical and social identity of an ethnic group, and has justifications arising from a philosophical interpretation. Summarizing on the basis of the Kazakh worldview such new rhythms of civilization in the process of spiritual rebirth, the importance of harmonious interaction with the process of world culture and civilizational development, the importance of strengthening the national mentality is shown.
- within the framework of the ideas of "Adil Kazakhstan" and "Unity of the Nation", a promising model for strengthening national identity has been put forward, scientifically based proposals have been put forward that reveal its complex structure. The main objectives of identity policy should be the education of talented youth, the cultivation of

human capital, and the creation of real opportunities for the younger generation to make a significant creative contribution to the development of world civilization.

The main results of the research: the philosophical and methodological foundations of the study have been developed, the content of the concepts of "national identity" and "succession of generations" has been revealed, the role and significance of the succession of generations in the preservation and improvement of national identity within the framework of the "New Kazakhstan" strategy has been comprehended, hermeneutic, axiological and futurological analysis of the existence of the Kazakh people with reasonable optimistic conclusions for the future has been carried out.

Substantiation of the novelty and significance of the results obtained, their compliance with the directions of scientific development or government programs:

- an elective course program has been prepared on the topic "The place and role of generational succession in preserving national identity" as a component of the curriculum selection;
- the results obtained can be used in the preparation of training courses "Philosophy of Culture", "The problem of national identity", "Continuity of generations" and the assimilation of conclusions of a socio-cultural, ideological, value nature within the framework of the national idea "Unity of the Nation" and the strategy "New Kazakhstan";
- the position is substantiated that the concept of national identity in its interrelation with the concept of generational continuity contributes to the formation and development of a national ideology designed to awaken national consciousness, educate young people in the spirit of patriotism, respect for national values.

Novelty and significance of the results:

- the concept of continuity is considered as a socio-philosophical phenomenon, its semantic foundations are revealed. The conceptual ideas expressed about continuity are interpreted in a new way and its specific logical definition is put forward;
- the content of the concept of succession of generations is revealed and its original interpretation is presented;
- the philosophical meaning is analyzed and the definition of the concept of national identity is proposed, specific manifestations of national identity in the history of human development and at the present stage are studied;
- a critical analysis of the concepts of ethnicity, nation, nationalism, patriotism, ethnic and civil nation in the light of the conceptual justification of the state identity policy is carried out:
- in search of information security in the era of globalization, specific mechanisms for preserving national identity are presented in connection with possible threats such as "American hegemony", the revival of the colonial policy of the Russian world, "Arabization" and Islamization, Westernization, etc.;
- the scientific and theoretical foundations of the technology of preserving national identity in the context of multiculturalism have been studied;
- the improvement of national identity on the basis of the continuity of generations, in accordance with the ideas of "Unity of the Nation" and the strategy of "New Kazakhstan", is justified as a priority direction of modern identity policy in the country.

Description of the doctoral student's contribution to the preparation of each publication (the contribution of the author of the dissertation is reflected as a percentage of the total text)

16 scientific articles have been published on the topic of the dissertation.
