Name of the project	AP19577160 Modern environmental Law and order: Kazakhstan case
Relevance	<p>The topic of the project is devoted to one of the fundamental legal problems of our time – environmental law and order, its components and efficiency problems.</p> <p>The relevance of the research topic is given by the high level and diversity of environmental problems both in Kazakhstan and on the planet Earth as a whole. Environmental problems lead to a deterioration in the quality of life, negative social, economic, and political problems.</p> <p>Currently, the relevance of ensuring international law and order is beyond doubt. Various conflicts between regions and countries, the threat of a global environmental crisis, and even the threat of ensuring peace demonstrate the imperfection of the United Nations security mechanism in a huge number of contradictions.</p> <p>The topic of the project is interesting not only from the theoretical, but also from the practical side. The modern stage of Kazakhstan's development has actualized the problems of civil society institutions, the economy, and the vertical of state power. These problems overshadow the issues of interaction between society and its environment. Meanwhile, these issues directly affect the level and quality of life of each individual citizen. Thus, the economy solves social problems, and its basis is the exploitation of raw materials, which, in turn, threatens the human environment.</p> <p>The problem of environmental law and order covers not only environmental rights, but also the right to life itself. In the event of a large-scale environmental disaster, not only the environmental rights of the individual, but also all others, will lose their meaning.</p>
Purpose	The purpose of the project is to study the current state and problems of environmental law and order, and to develop practical recommendations for improving the legislation of the Republic of Kazakhstan in the field of environmental law and order.

Expected and achieved results	<p>The following results will be achieved during the implementation of the project:</p> <ul style="list-style-type: none"> - The conceptual apparatus is defined, the structure is defined and the main characteristics of the ecological legal order are considered, the ecological legal awareness in the structure of the elements of the ecological legal order is investigated; - national and international principles of environmental law and order are classified; - the rights and obligations of subjects of environmental law and order are structured, the role and powers of public associations in ensuring environmental law and order will be determined; - the problems of environmental law and order management are analyzed, the correlation of environmental law and order with environmental safety will be revealed; - legal ways of protecting environmental law and order, legal responsibility and the role of law enforcement agencies, as well as the right of citizens to self-defense in ensuring environmental law and order are considered; - recommendations have been developed to improve the legislation of the Republic of Kazakhstan in the field of ensuring environmental law and order. <p>in the process of completing the research tasks, the following associated project results will also be achieved:</p> <ul style="list-style-type: none"> - at least two articles will be published in peer-reviewed scientific publications included in the second or third quartile, the Social Science Citation Index or the Arts and Humanities Citation Index of the Web of Science database, and (or) having a CiteScore percentile in the Scopus database of at least thirty-five. Each article will contain information about the identification registration number and the name of the project under which it was funded, indicating grant funding from the Ministry of Education and Science of the Republic of Kazakhstan as a source; - at least ten articles will be published in peer-reviewed foreign and (or) domestic publications recommended by COXON. Each article will contain information about the identification registration number and the name of the project under which it was funded, indicating grant

funding from the Ministry of Education and Science of the Republic of Kazakhstan as a source;

- at least three collections of conference materials will be published;

- the monograph will be published in foreign and (or) Kazakhstani publishing houses;

- at least two copyright certificates will be obtained from the Kazakh or Eurasian Patent Office;

- educational and methodological documentation will be developed;

- activities will be carried out to disseminate knowledge and results obtained during the implementation of the program among potential users, the community of scientists and the general public.

Other measurable results:

To popularize science, disseminate information about the results, and increase the likelihood of their implementation, a separate website will be created, which will contain brief information about the project: relevance, purpose, expected and achieved results, names and surnames of members of the research group with their identifiers (Scopus Author ID, Researcher ID, ORCID, if available) and links relevant profiles, a list of publications (with links to them) and patents; information for potential users. The information on the web page (or website) will be updated regularly (at least once a month). For each scientific publication within the framework of the project, information about its content and possible application will be published on the website and on social networks.

The direct target consumers of the project results are the legislator, the scientific community, and the education sector acts as an indirect consumer. New source data will be obtained; modern innovative methods of work will be put into practice, contributing to the expansion of the presence of public environmental organizations in Kazakhstan, and the popularization of their activities in the form of methodological materials; modern communication methods and technologies will be applied; the environmental situation of citizens of Kazakhstan will be influenced.

The expected social and economic effect.

The effect of this study is that the results of the project will have a significant impact on the further development of the theory of environmental law as a legal science. The results of the study are important for the whole complex of social sciences and humanities.

The proposals developed during the study will allow for a more precise definition of the environmental functions of the state and society in the field of strengthening environmental law and order. The analysis of various ways to protect environmental law and order fills the concept of
