1. Relevance of the study.

Serikbayeva Aizhan's dissertation research is devoted to the current topic of linguistic innovation in virtual communication in modern linguistics. The relevance of the topic lies in the fact that in addition to linguistic innovations in virtual communication, the problems of codification and lexicography of linguistic innovations are considered. This problem remains relevant in world linguistics.
