

Brief information about the project

Name of the project	AP19675827 «Philosophy of language and the language of philosophy in the teachings of Abu Nasir Al-Farabi»
Relevance	The project "philosophy of language and the language of philosophy in the teachings of Abu Nasir Al-Farabi" examines the problem of philosophy of language, language as a subject of linguistics, determines the relationship of philosophy of language with logic and analyzes terms and interpretations in the works of Abu Nasir. The philosophy of language is not just a field of studying the connection of philosophy between thinking and language, it allows us to determine the communicative role of language, various forms of words and speech in discourse, the role of consciousness and knowledge in cognition.
Purpose	Purpose of the project – Problems of language philosophy and the language of philosophy in the teachings of Abu Nasir Al-Farabi: the basis of language and consciousness, the study of the continuity of logic and grammar and the features of the formation of philosophical terms.
Objectives	<ul style="list-style-type: none"> - to analyze the history of the development of the main problems of the philosophy of language, to show their importance for the development of the scientific paradigm of social and humanitarian knowledge - Providing quantitative and qualitative definitions of bibliographic data on the scientific heritage of Al-Farabi - definition of the philosophical (ontological, methodological, epistemological, axiological) foundations of Al-Farabi's teaching about language - the study of the features of his treatises on the philosophy of Language, linguistic and logical problems in the legacy of Al-Farabi - Analysis of the problem of language in the " classification of sciences " from the point of view of linguistic discourse - setting philosophical problems of language in contact with logic - To explain the terms introduced by Abu Nasr in the framework of the language of philosophy and to give a philosophical justification for the actual problems and methodological principles of his linguistic research. - The study of the conceptual and categorical apparatus of Al-Farabi's views on terms and terminology - formation of a dictionary of philosophical terms in the Arabic-Russian-Kazakh language based on the philosophical works of Al-Farabi.
Expected and achieved results	<p>Expected results:</p> <p>To study the quantitative and qualitative characteristics of bibliographic data, the stages of the study of the heritage of scholar Al-Farabi are determined and systematized, the main trends in Farabi studies are reasoned based on bibliographic sources of foreign experience.</p> <p>To determine the historical stages of the study of Al-Farabi's works, the characteristics of Al-Farabi's heritage and Farabi studies in the Soviet period are studied, the priority directions of the study of Al-Farabi's heritage are determined, the difficulties and main problems in translating Farabi's works, and the features of translation due to ideological positions are analyzed.</p>

Current, i.e., research in the field of domestic Farabi studies during the years of independence, examine the new aspects of the study of Al-Farabi's heritage, features of the developed worldview in the context of Muslim culture, and give a comparative assessment of the translated works carried out within the framework of the "Madeni Mura" (Cultural Heritage) program. The works of the thinker, which have never been translated before and have not entered scientific circulation, are studied, and formulated.

In order to analyze the problem of the philosophy of language in Al-Farabi's teaching, an explanation is made of the main aspects of the philosophy of language and the reasons for its emergence. Analysis of the development history of the main problems of the philosophy of language, their importance for the development of the scientific paradigm of social and humanitarian education is determined.

Philosophical foundations will be determined of Abu Nasir al-Farabi's teaching on language (ontological, methodological, epistemological, axiological),

an expertise will be made based on thinker's theoretical and methodological foundations.

The connection between language and consciousness, the connection between internal and external thought, the history of the origin of words and the peculiarities of communication, the interdependence of grammar and logic, the parallels between the locality of language and the universality of thinking and logic are studied based on al-Farabi's treatises. The conclusion is presented in the form of a collective monograph.

Logico-linguistic continuity of language and thinking will be studied based on Al-Farabi's "Ihsa al-Ulum" and "Kitab al-Khuruf" and other works related to language and logic. The equivalence of logical and linguistic terms will be considered on the example of the Arabic language.

During the study, the terms introduced by al-Farabi in the framework of the language of philosophy will be explained, and the actual problems and methodological principles of his linguistic research will be given a philosophical basis, and a conceptual analysis of philosophical terms will be made.

A dictionary of philosophical terms in Arabic, Russian and Kazakh languages will be compiled for the purpose of correct use of terms in scientific research and the peculiarities of its formalization will be determined.

Philosophical terms are printed based on Farabi studies.

Results achieved:

- The stages of studying the heritage of al-Farabi were studied and systematized to determine the quantitative and qualitative characteristics of bibliographic data, the main directions of Farabi studies were considered based on foreign bibliographic sources.

- the features of Farabi studies and research on the study of al-Farabi's heritage in the Soviet period are determined in order to identify the historical stages of the study of al-Farabi's works, priority directions in the study of al-Farabi's heritage are explored, the main problems in translating the thinker's creative heritage are identified, the influence

Previously untranslated and not included in scientific circulation, the works of the thinker were studied. 2 articles were published in publications recommended by KOKSON Ministry of Education and Science of the Republic of Kazakhstan</p>
