Relevance	The proposed project aims to examine the existing immigration policies of Kazakhstan, and its impact on the identity formation and integration of ethnic repatriates who came to Kazakhstan. Several laws and policies with different objectives and priorities have been adopted to address the immigration of repatriates over the last three decades. Scholarly studies have suggested that these laws and policies do not provide the necessary support and assistance for repatriates to settle successfully in their new country. This suggests that a systematic study is required to determine why ethnic repatriates are unable to integrate into Kazakhstani society.
Purpose	Identify cultural and social challenges associated with Kazakh repatriates' integration into Kazakhstani society and suggest solutions.
