	communication within society. Additionally, substantiates the necessity for religious studies to discern the psychological and social foundations of adolescents within the secondary education system. • Determine the placement of religious studies within the
	framework of secondary and secondary specialized education in Kazakhstan. Present the results of a

comprehensive survey conducted in each region, outlining the collective assessment of the need for teaching religious studies in schools and specialized educational institutions. Provide these results to relevant ministries for effective planning of future initiatives.
